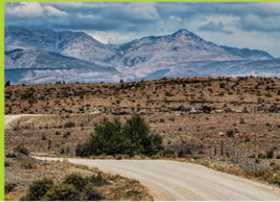

- Ufanele ucaciswe yingcali yamanzi ngezinto eziphilayo nendawo eziphila kuyo

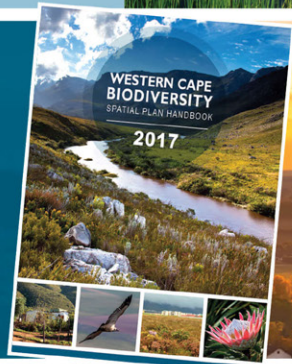


Western Cape Biodiversity Spatial Plan (WCBSP)

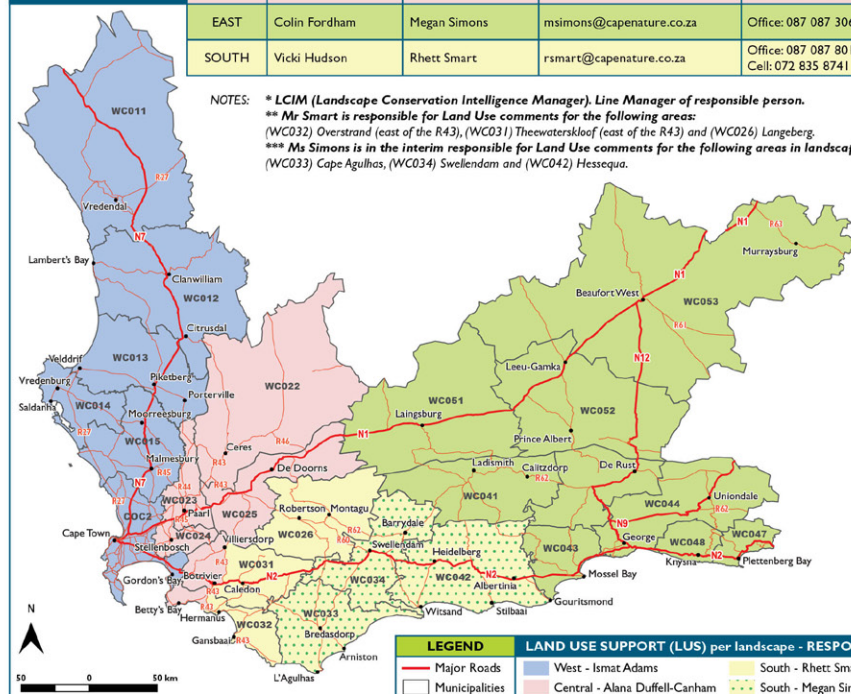
